COMES NOW, Shawn P. Sant, Franklin County Prosecuting Attorney, and by this Information accuses **MONICA LOU PRUETT** of the crimes of:

COUNT I

**THEFT IN THE FIRST DEGREE, [RCW 9A.56.020(1)(A) AND 9A.56.030(1)(A)], A CLASS B FELONY**, committed as follows:

That the said **MONICA LOU PRUETT** in the County of Franklin, State of Washington, on or between June 1, 2005, and April 30, 2012, then and there, did wrongfully obtain or exert unauthorized control and/or by color or aid of deception obtain control over property, belonging to William Christian Swensen, DBA: D&S Farms, of a value exceeding five thousand dollars (\$5,000.00) with the intent to deprive William Christian Swensen of such property and FURTHERMORE, the crime was aggravated by the following circumstances pursuant to RCW 9.94A.535(3)(d), the current offense was a major economic offense and/or series of offenses so identified by the following factors: (1) the current offense involved a monetary loss substantially greater than typical for the offense, and/or (2)


4 **MONEY LAUNDERING, [RCW 9A.83.020], A CLASS B FELONY**, committed as  
5 follows:

6 That the said **MONICA LOU PRUETT** in the County of Franklin, State of Washington,  
7 on or between June 1, 2005 and April 30, 2012, then and there, did conduct or attempt to conduct a  
8 financial transaction involving the proceeds of specified unlawful activity, to wit: stolen  
9 money, knowing such stolen money was the proceeds of specified unlawful activity and/or knowing  
10 that the transaction is designed in whole or in part to conceal or disguise the nature, location, source,  
11 ownership, or control of the proceeds, and acts recklessly as to whether the property is proceeds of  
12 specified unlawful activity and FURTHERMORE, the crime was aggravated by the following  
13 circumstances pursuant to RCW 9.94.535(3)(d), the current offense was a major economic offense  
14 and/or series of offenses so identified by the following factors: (1) the current offense involved  
15 monetary loss substantially greater than typical for the offense, and/or (2) the current offense involved  
16 multiple incidents, and/or (3) the defendant used his or her position of trust, confidence, or fiduciary  
17 responsibility to facilitate the commission of the offense.
