On January 27, 2012, post Miranda, Williams admitted that God had sent a guiding light and Angels to him. The light directed he kill Viola Williams, Adam Williams grandmother. (Williams referred to himself in the third person and told me that the person I was presently interviewing was "Lucifer Grand Am Dynasty") Williams stated that he was told that Viola was an "extorter" and a ring leader which led to his being raped by his brothers since the age of eight.

Williams stated that he put foil, lighter fluid, a pair of gloves and a belt in his back pack to complete this task. He got on a Ben Franklin bus in West Richland where he resides and traveled to 19th and Highway 395. He then proceeded to 87 year old Viola's home at 3324 W 19th Ave, Number 165. He was inside the residence with Viola when he got very angry with her and punched her in the head. Williams stated that she fell to the floor and he put his boot on her throat and then the belt he brought with him around her neck. Williams said he attempted to pull her head off, but the belt broke. Williams said he then took the tin foil he had brought with him and stuffed it Violas mouth and tried to suffocate her. This was unsuccessful so Williams then took a plastic bag and held it around her mouth, Williams said he could see her breathing. In an effort to kill her he then poured lighter fluid on her face and lit her on fire. This also failed, so Williams then took a knife from the kitchen and stabbed Viola in the chest. He added then tried to cut her jugular vein, but could not find a knife sharp enough. He stabbed Viola in the throat and left the knife there when God told him that was enough.

Williams stated that he discarded a pair of bloody gloves and the lighter fluid in a neighboring yard. On January 27, 2012, at about 1458 hours, Sherrie Lennox went to check on her mother, Viola Williams, because Viola failed to answer the phone. Sherrie found her mother dead with a knife in her neck. Lennox is an Aunt to Adam Williams. The bloody gloves were found and brought to police on scene by two juveniles who found them. During a search of the area where the gloves were found officers located a can of lighter fluid.
