On July 30, 2012, an undercover female Kennewick Police Officer entered the China Sun Foot Massage, 7903 W Grandridge, and requested a full body massage. Zhen, also known as Linda and an employee of the China Sun directed the officer to remove her clothes and lay on the massage table. The officer did so. The officer reported that she left a thong panty on. Zhen covered the officer's head with a towel and straddled the officer with Zhen's crotch towards the back of the officer's head. Zhen pulled the officer's panties down and left her exposed from the waist down. Zhen then massaged the inner thighs of the officer and came in contact with her vagina several times with her hands. Zhen then pulled the officer's panties up, taking time to straighten the straps and "snapping" them afterwards. On August 14, 2012, the officer identified Zhen in person as being the masseuse in question.

On August 2, 2012, Terry Trulson, a retired Pasco Police Detective Sergeant, went into the China Sun Foot Massage, 7903 W Grandridge, to receive a full body massage in an undercover capacity. Trulson reported Zhen instructed him to disrobe and lay on the massage table. Trulson reported Zhen left him undercover at times during the massage. Zhen did not grasp his penis, but rub it while using her forearm to massage his inner thighs. Trulson identified Zhen through a photograph I sent him.

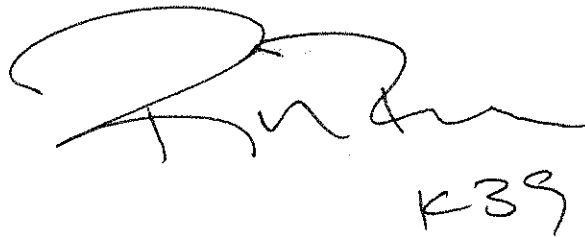
On July 27, 2012, a female citizen victim arrived at the China Sun Foot Massage, 7903 W Grandridge, Suite L, to receive a full body massage. Sun, also known as Susan, and an employee of the China Sun, had the victim disrobe and lay face down on the massage table. The victim was left completely exposed at least one time. Sun's hand came in contact with the victim's vagina several times while massage her inner thighs. Sun also removed her pants, climbed onto the victim's back to massage the victim with her knees. The victim reported she knew this because she heard Sun unzip her pants and pull them off. In addition, the victim described feeling skin on skin. On August 14, 2012, the victim came to the Kennewick Police Station and identified Sun among several other China Sun employees.

On August 6, 2012, Terry Trulson, a retired Pasco Police Detective Sergeant, went into the China Sun Foot massage in an undercover capacity. He was provided a two hour full body massage by Sun. Trulson stated that Sun did not grasp his penis but came in contact with or brushed his penis and testicles. Trulson also reported that Sun removed the towel from his buttocks and ran her thumbs and fingers between his buttocks. Trulson positively identified Sun through a photograph I sent him.

Li Cui is the owner/manager of the China Sun, 7903 W Grandridge and 3321 W Kennewick Ave. Post Miranda, Cui admitted that he employed five masseuses at the businesses. These employees included Zhen and Sun. All the masseuses preformed both foot and full body massages. Cui admitted that he knew that they did not have Washington State Masseuse licenses as required for body massages. Cui

stated that he paid the employees \$800.00 a month and they returned \$300.00 each month for rent of an apartment that housed them all. The masseuses worked 10 am to 10 pm, seven days a week.

While serving search warrants at the businesses it was determined Zhen and did not have a copy of her Washington State Masseuse license on their person or place of business as required. RCW 18.130.190.7A which constitutes a gross misdemeanor for a first time offense of practicing without a license while a second offense is a Class C Felony.
